SENATE LEGISLATION

SB-06SB-2042

1 **SB-06SB-2042 : Title III Revisions**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Constitution and Statutes Committee is a standing committee of the Student Government
5 Senate, responsible for reviewing and maintaining the Constitution and Statutes of the
6 Student Government of the University of North Florida. It is the job of this committee to
7 make revisions to the Constitution and Statutes as needed

8 Whereas: Title III is in need of revision:

9 Whereas: Section 303.7 of Title III states "All executive Cabinet members are a required to
10 give a written report at the first senate meeting of each term and thereafter
11 alternating Senate Meetings with an oral report to be given by the respective
12 cabinet member. If a cabinet member is unable to attend, then a written report
13 shall be submitted instead"

14 Whereas: Section 302.2 of Title III states "The Student Government President has sole
15 power of appointment within the Executive Office and may dismiss at his/her
16 discretion, any appointment at any time with the exception of the Student
17 Government Treasurer."

18 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
19 **that Section 303.7 of Title III be permanently removed from the Statute, and**
20 **that "Attorney General" be added to Section 302.2 after the "Student**
21 **Government Treasurer".**
