1		SB-06SB-2042 : Title III Revisions
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7	Whereas:	The Constitution and Statutes Committee is a standing committee of the Student Government Senate, responsible for reviewing and maintaining the Constitution and Statutes of the Student Government of the University of North Florida. It is the job of this committee to make revisions to the Constitution and Statutes as needed
8	Whereas:	Title III is in need of revision:
9 10 11 12 13	Whereas:	Section 303.7 of Title III states "All executive Cabinet members are a required to give a written report at the first senate meeting of each term and thereafter alternating Senate Meetings with an oral report to be given by the respective cabinet member. If a cabinet member is unable to attend, then a written report shall be submitted instead"
14 15 16 17	Whereas:	Section 302.2 of Title III states "The Student Government President has sole power of appointment within the Executive Office and may dismiss at his/her discretion, any appointment at any time with the exception of the Student Government Treasurer."
18 19 20 21	Therefore:	Let it be enacted, by the University of North Florida Student Government, that Section 303.7 of Title III be permanently removed from the Statute, and that "Attorney General" be added to Section 302.2 after the "Student Government Treasurer".
