6 7 8 9 10 11 12	1200.1	The Student Advocacy Committee is one of the four standing committees of the Student Government Senate. The Student Advocacy Committee is responsible for acting as a liaison between the University of North Florida's student body and the Student Government, and promotes those programs and activities, locally or nationally, which are in the interests of the University of North Florida.		
13 14 15 17 18 19 20 21	1200.2	The Student Advocacy Committee shall be composed of up to eleven SG Senators including the Chairman and ten SG senators. All voting members of the committee will be elected or appointed senators including the Vice Chairperson. Non-voting Ex-Officio members shall include Constitutions and Statutes (CSC) Chairperson, Budget and Allocations (B&A) Chairperson, Elections, Selections, and Appointments Committee (ESAC) Chairperson, Senate President, Senate Pro-Tempore and Faculty Association Representative; SG Advisor.		
22 23 24 25	1200.3	All special requests for SAC sanctioned events are required to go through first reading in the Student Advocacy Committee.		
26 27 28	1200.4	The Student Advocacy Committee has the ability to amend, approve, or disapprove any special request for SAC sanctioned events.
