1 **SB-07F-2160 : Student Council for Exceptional Children**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Student Council for Exceptional Children wishes to travel to the Bahia Mar
12 Beach Resort and Yachting Center in Fort Lauderdale, Florida for the sake of
13 attending the Florida Council for Exceptional Children Conference departing
14 October 11, 2007 and returning October 13, 2007.

15 Registration: \$80.00 Lodging: \$129.00 Transportation: \$116.60

16 **Total: 325.60**

17 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
18 **that \$325.60 from the Travel Request Index 402028 be used to pay for the**
19 **above referenced items.**
