SENATE LEGISLATION

SB-07F-2180

1 **SB-07F-2180: Student Physical Therapy Association**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Government has the obligation to promote student activities and service their general
interests;

13 Whereas: The Student Physical Therapy Association represents student interest.

14 Whereas: For the Student Physical Therapy Association to attend the American Physical
15 Therapy Association's Combined Sections Meeting being held in Nashville,
16 Tennessee, February 6th-10th, 2008.

17 Lodging (Half): 2 rooms at \$109 and \$139 per night for 4 nights = \$496

18 Transportation: Vehicle = \$22 per day x 2 vehicles x 2 days = \$88

19 Airfare = \$238 x 8 students = \$1904

20 **Total: \$2,488**

21 **Therefore:** Let it be enacted, by the University of North Florida Student Government, that
22 \$2,488 be used from the Travel Index 402028 for the Student Physical Therapy
23 Association trip.
