# SENATE LEGISLATION

## SB-07F-2184

### SB-07F-2184 : Revision of Candidate Seminar

1  
2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts  
6 that are necessary and proper for the Student Body of the University of North  
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be  
9 considered by Student Senate;

10 Whereas: The Elections Statutes is in need of a minor revision;

11 Whereas; The following changes will be made to Title VI section 604.1.C. to better serve  
the student in a more reasonably manner;

13 C. Attend a mandatory Candidate Seminar which shall be held on at least  
14 three (3) separate dates prescribed by the Elections Supervisor to obtain  
15 the Candidate Seminar Document. All candidates must attend one of the  
16 scheduled seminars or meet with the Elections Supervisor to qualify for  
17 candidacy. All information discussed in ~~one~~ seminars shall be ~~shared with~~  
18 all candidates via website, email, public notice or later Candidate Seminar  
19 previously approved by the ESAC committee. All additional questions  
20 answered will be shared via public notice and email.

21 \*\*NOTE: In the event of an extenuating circumstance the candidate may  
22 request a meeting with the Elections Supervisor in replacement of the  
23 Candidate Seminar by obtaining the signatures of at least four (4) ESAC  
24 committee members (excluding the chair). This will only be granted in  
25 extenuating circumstances at the pervue of the ESAC committee.\*\*

26 **Therefore: Let it be enacted, by the University of North Florida Student Government**  
27 **that this revision of Title VI be made effective immediately.**
