6		SB-07S-2085 - Revision to Title VII
7 8	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
9 10 11	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government, given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida;
12 13	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by the Student Senate;
14 15	Whereas:	Title VII conflicts with the recently enacted Constitutional amendment for the position of Student Government Attorney General;
16 17	Whereas:	Chapter 301.1.E has been revised to mandate the position of Student Government Solicitor General;
18	Whereas:	Chapter 706 should read:
19		Chapter 706 Attorney General's Solicitor General's Responsibility
20 21 22		706.1 As outlined in Title IV III, the Attorney General Solicitor General shall advise the accused party on all relevant legal matters pertaining to the noncompliance and assist the accused party in their defense
23 24		706.2 The Attorney General Solicitor General shall serve as the defense council upon the request of the accused party
