SB-07S-2110: Campus Recreation

- 2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government Senate,
5 responsible for funding only those entities that comply with the Student Government mission which is
6 to represent student concerns in all university wide matters while developing and promoting programs
7 and activities of practical value and interest to students, and;
- 8 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational, social,
9 cultural, and recreational interests of the University of North Florida students and;
- 10 Whereas: Student Government has the obligation to promote student activities and service their general
11 interests;
- Whereas: Campus Recreation exists to provide students, faculty, and staff with a wide variety of
13 recreational and social activities
- 14 Whereas: Campus Recreation wishes to pay an OPS student to open, close, inspect, and pull trash at
15 the skate park April 1, 2007 – June 30, 2007 and to purchase permanent signs for the
16 skate park.
- 17 Whereas: The Campus Recreation Bill is for student enhancement. For the organization's
