# SENATE LEGISLATION

## SB-07S-2117

### SB-07S-2117 - Revision to Title VII

6

7 Whereas: The Student Government of the University of North Florida was established to represent  
8 student concerns in all University wide matters, and;

9 Whereas: The Student Senate is the legislative body of the University of North Florida's Student  
10 Government, given the responsibility of carrying out such legislative acts that are  
11 necessary and proper for the Student Body of the University of North Florida;

12 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by  
13 the Student Senate;

14 Whereas: Title VII conflicts with the recently enacted Constitutional amendment for the position of  
15 Student Government Attorney General;

16 Whereas: Section 706 has been revised to mandate the position of Student Government Solicitor  
17 General;

18 Whereas: Chapter 706.1 should read:

19 Chapter 706 ~~Attorney General~~ Solicitor General Responsibility

20 706.1 As outlined in Title IV, the ~~Attorney General~~ Solicitor General shall may advise the  
21 accused party on all relevant legal matters pertaining to the noncompliance and assist the  
22 accused party in their defense.

24 706.2 The ~~Attorney General~~ Solicitor General shall may serve as the defense council upon  
25 the request of the accused party.

27 Therefore: Let it be enacted by the University of North Florida Student Government that these  
28 changes to Title VII be made effective on immediately.
