# SENATE LEGISLATION

## SB-07S-2119

### *SB-07S-2119 - Identifies Activity & Service Fee Fund Balance Restricted Reserves*

- 2   Whereas:       The Student Government of the University of North Florida was established to represent  
3                    student concerns in all University wide matters, and;
- 4   Whereas:       Legislation dealing with necessary and proper statutory revisions shall be considered by  
5                    the Student Senate;
- 6   Whereas:       Title VIII, Section 830.3 creates a misimpression that Student Government is under-  
7                    spending its budgets by budgeting cash that would be more appropriately treated as  
8                    reserves;
- 9   Whereas:       Student Government expressed its preference, in line 8 of the 2007-2008 Activity &  
10                   Service Fee Budget Provisionary Language, that a portion of the Fund Balance equal to  
11                   the operational cost of the first quarter of the 2006-2007 Fiscal Year be held in a Cash  
12                   Flow Reserve;
- 13   Whereas:       Student Government expressed its preference, in line 19 of the 2007-2008 Activity &  
14                   Service Fee Budget Provisionary Language, that the amount remaining in the Fund  
15                   Balance after all reserves and restrictions have been met be held in the General Reserve;
- 16   Whereas:       The following changes to Title VIII would more accurately identify the Activity & Service  
17                   Fee reserves:
- 18                   801.8 - Fund Balance - An accumulation of money generated through excess  
19                   tuition hours and unexpended budget allocations.
- 20                   801.15 - Scholarship (Operating) Reserve - The portion of the Fund Balance  
21                   designated in the amount of at least \$600,000 for the purpose of generating  
22                   interest to provide funds for annually awarded Student Government  
23                   Scholarships.
- 24                   801.16 - Cash Flow (Operating) Reserve - The portion of the Fund Balance  
25                   designated in the amount of at least \$100,000 to meet liabilities at the beginning  
26                   of the fiscal year.
- 27                   801.17 - General (Equipment) Reserve - The portion of the Fund Balance after all  
28                   other reserves and restrictions are met.
- 29                   830.3 - Any Carry Forward Funds and additional revenues up to \$100,000 shall  
30                   be placed in the Special Requests Index. In the event that Carry Forward Funds  
31                   exceed that amount, the excess will be placed in the General Reserve portion of

32 the Fund Balance. These funds shall be released following the normal legislative  
33 process.

34 Therefore: Let it be enacted by the University of North Florida Student Government that these  
35 changes to Title VIII be made effective on March 26,2007.
