SB-12F-2468: Validation of Fall 2012 General Elections Results

2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University wide matters;
4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student
5 Government given the responsibility of carrying out such legislative acts that are necessary and
6 proper for the Student Body of the University of North Florida;
7 Whereas: As provided for by the Student Government Constitution and Title VI, the Fall 2012 General
8 Elections were properly conducted;
9 Whereas: Title VI requires the results of each election be drafted by the Elections Commission and
10 forwarded to Senate to be validated at the Senate meeting following the elections;
11 Therefore: Let it be enacted that the Fall 2012 General Elections results be validated as written below:
