### SB-12SA-2602: Osprey Productions

- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Osprey Productions is an Activity and Service fee funded department, looking to enhance the  
12 cultural and social interests of the students of the University of North Florida, and;
- 13 Whereas: Osprey Productions, in order to further enhance the cultural and social interests of the  
14 students of the University of North Florida, are seeking funding for new follow spot lights.
- 15 Whereas: Opsrey Productions is requesting funding for the below item:
