- 4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission, which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;
- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,
10 cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Student Government Executive Branch wants to create a more efficient office area in the
12 Student Government offices and;
- 13 Whereas: Student Government Executive Branch is requesting the following:
