# SENATE LEGISLATION

## SB-12F-2628

1 **SB-12F-2628: Statute of Limitations Reform**

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts that  
6 are necessary and proper for the Student Body of the University of North Florida;  
7 and

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered  
9 by Student Senate; and

10 Whereas: Title VI is being further updated and changed.

11 **Furthermore:** The following revisions are being proposed to Title VI;

12 **TITLE VI: THE ELECTION CODE**

13 **Chapter 605: Elections Supervisor**

14 605.2 All decisions made by the Elections Supervisor may be appealed to  
15 the elections courts within two (2) business days from candidate  
16 notification, unless defined otherwise in the Elections Timeline.

17 **Chapter 606: Elections Commission**

18 606.5 All decisions made by the Elections Commission may be appealed to  
19 the elections courts within two (2) business days from candidate  
20 notification, unless defined otherwise in the Elections Timeline.

22 **Therefore:** Let it be enacted, by the University of North Florida Student Government that the  
23 proposed revisions to Title VI be made effective immediately.
