SENATE LEGISLATION

CR-12F-2629B (A)

1 *CR-12F-2629B (A):Constitutional Referendum II Addendum*

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government given the responsibility of carrying out such legislative acts that
6 are necessary and proper for the Student Body of the University of North Florida;
7 and;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered
9 by Student Senate; and

10 Whereas: The Constitution is in need of revision.

11 **Furthermore:** The following revisions are being proposed to the Constitution;

12 **ARTICLE IV: THE JUDICIARY**

13 **Section 2: Composition of the Judicial Council**

14 C. ~~An Associate Chief Justice shall be appointed annually from within the Judicial Council by~~
15 ~~the Chief Justice and shall assume the duties of the Chief Justice in the event of his/her~~
16 ~~absence.~~

17 ~~C. D.~~ Other officers that the Council deems necessary shall be chosen according to Judicial Rules
18 and Procedures.

19 **Section 7: Administration: Practice and Procedure**

20 ~~C. In the absence of the Chief Justice, an interim Chief Justice shall be designated according to~~
21 ~~Judicial Rules and Procedures.~~

22 **Therefore:** Let it be enacted, by the University of North Florida Student Government that the
23 proposed revisions to the Constitution be forwarded to the Student Body separate
24 from its parent bill.
