1 **SB-12F-2631: Executive Branch On-Campus Dining Renovations**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission, which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,
10 cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Government Executive Branch wants to improve campus dining by renovating
12 buildings to bring new, well-known franchises to UNF and;

13 Whereas: Student Government Executive Branch is requesting the following:

15 Building 58 West Renovations = \$209,549.00
16 Building 8 Renovations = \$463,251.00

18 **Total: = \$672,800.00**

20 **Therefore: Let it be enacted, by the University of North Florida Student Government, that**
21 **\$209,549 be taken from Student Union Student Fees Fund Balance Index 154200 and**
22 **that \$463,251.00 be taken from Fund Balance Index 402000 to be used to pay for the**
23 **above items.**
