# SENATE LEGISLATION

## SR-12F-2638

1 *SR-12F-2638: Service Member Appreciation Act*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts that  
6 are necessary and proper for the Student Body of the University of North Florida;  
7 and;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered  
9 by Student Senate; and

10 Whereas: The Senate Policies and Procedures are in need of revision

11 **Furthermore:** The following revisions are being proposed to the Senate Policies and Procedures;

12 **III. Senate Officers and Their Duties**

13 **B. Senate President**

14 22. Following the Pledge of Allegiance and Invocation, the  
15 Senate President shall recognize veterans of the Armed  
16 Forces of the United States of America that are present in the  
17 guest area of the Senate Chambers. In addition  
18 this recognition should apply to family members of the  
19 Veterans and active duty service members.

20 **Therefore:** Let it be enacted, by the University of North Florida Student Government that the  
21 proposed revisions to Senate Policies and Procedures be made effective immediately.
