JR-12F-2649

1 *JR-12F-2649 : Support of Brand Name Dining Enhancements*

2 Whereas: The Student Government of the University of North Florida was established to
3 create a representative government through which the individual student voice can
4 be heard, and which students can actively participate in this University by promoting
5 cooperation among the Student Body, Faculty, and Administration, and;

6 Whereas: The Student Government of the University of North Florida was established to
7 represent student concerns in all University wide matters; and

8 Whereas: The Student Government of the University of North Florida has previously
9 supported Student Affairs' Club House initiative as evidenced in JR-11F-2555. We
10 continue to support the initiative as we recognize the importance of providing
11 another student-oriented facility that will further the Osprey experience.

12 Whereas: The Student Government of the University of North Florida recognizes the
13 importance of providing brand name dining options on campus. This belief is
14 affirmed by the great popularity of the brand name options on campus such as
15 Starbucks, Jamba Juice, and Quiznos. Although we recognize the strides our campus
16 has made in this area, we hope to continue these efforts in the Club House.

17 Whereas: The Student Government of the University of North Florida, as a result of recent
18 student surveys, suggests that a "Pita Pit" or "Angie's Subs" is chosen as the food
19 vendor for the Club House. We believe that either brand name will greatly further
20 campus dining options and enhance the student experience;

21 **Therefore:** Let it be resolved that the Student Government of the University of North Florida
22 supports the selection of "Pita Pit" or "Angie's Subs" in the Club House.
