SENATE LEGISLATION

SR-13S-2670

1 *SR-13S-2670: Student Outreach Initiative*

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government given the responsibility of carrying out such legislative acts that
6 are necessary and proper for the Student Body of the University of North Florida;
7 and;

8 Whereas: The connection between a representative and his/her constituents is an essential
9 ingredient of a sound representative democracy. The Legislative Branch is seeking to
10 further cultivate and enrich this critical nexus in order to more ably represent the
11 best interests of our student body.

12 Whereas: Education and advocacy are the heart of this lofty initiative. Educationally, this
13 initiative is focused on proactively informing our fellow students of the inner-
14 workings of our branch and government. Conjunctively, this initiative is propelled by
15 active student engagement, specifically the discovery of individual student concerns
16 and a subsequent pursuit of remedying their concerns.

17 Whereas: Ideal application of this initiative would be for each Senator to engage at least one
18 student per week. Moreover, in this engagement the Senator would provide the
19 student with a brief overview Student Government, specifically the Legislative
20 Branch and the array of services it provides to the student body. Additionally, the
21 Senator would seek to discover the day-to-day concerns faced by the student body.
22 Lastly, those concerns deemed pressing and urgent, and within the scope of our
23 government, shall be pursued via all reasonable measures of our branch and
24 government.

25 Furthermore: Energetic implementation of this initiative is vital to the development and evolution
26 of the Legislative Branch as it seeks to elevate its efficacy and relevancy to the
27 student body on an unprecedented scale.;

28 Therefore: Let it be enacted, the University of North Florida Student Government Senate
29 declares its support of the Student Outreach Initiative.
