# SENATE LEGISLATION

## SB-13S-2687

1 **SB-13S-2687: Student Union Administration**

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission, which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,  
10 cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Union Administration is requesting funding for various infrastructure and operational  
12 improvement projects for the Student Union and;

13 Whereas: Student Union Administration is requesting the following:

15	Mity-Lite – oval black chairs	\$104.89 X 100	= \$10,489
16	Mity-Lite – oval black chairs shipping and handling		= \$825.53
17	All Purpose Glass & Mirror – glass doors	\$2,154 X 5	= \$10,770
18	Construction contingency 10% (glass doors)		= \$1,077
19	Pipe Works LLC	\$3,398 X 1	= \$3,398
20	Construction contingency 10% (pipe installation)		= \$339.80
21	ACUI Procure – furniture		= \$38,685
22	ACUI Procure – screen/trust		= \$4,997.81
