# SENATE LEGISLATION

## JR-13SB-2703

1 **JR-13SB-2703 : Declaration of Support for the Military & Veterans Resource Center Memorial**

2 Whereas: The Student Government of the University of North Florida was established to  
3 create a representative government through which the individual student voice can  
4 be heard, and which students can actively participate in this University by promoting  
5 cooperation among the student body, faculty, and administration, and;

6 Whereas: The Student Government of the University of North Florida was established to  
7 represent student concerns in all university wide matters; and

8 Whereas: The University of North Florida is ranked second in the State University System for  
9 the size of its population of veterans registered for classes, and;

10 Whereas: Jacksonville is considered one of the most 'Military-friendly' cities in the nation and  
11 is home to two active military bases, Naval Station Mayport and Naval Air Station -  
12 Jacksonville, and;

13 Whereas: The Student Government of the University of North Florida fervently believes in the  
14 importance of recognizing university affiliates who have served in our nation's  
15 military, and;

16 Whereas: The Student Government of the University of North Florida is proud to lend its  
17 support to the Division of Student and International Affairs, as well as the UNF  
18 Military and Veterans Resource Center to construct a memorial on campus to  
19 distinguish the patriots who defend our freedom and also call themselves 'ospreys,'  
20 and;

21 **Therefore:** Let it be resolved that the Student Government of the University of North Florida  
22 believes that the expedient fundraising and development of a memorial on campus is  
23 in the best interest of the student body and all UNF constituencies, and;

24 **Furthermore:** Let this resolution be forwarded to the Board of Trustees, President John Delaney,  
25 Interim Vice President of Development & Alumni Affairs, Ann McCullen, and Vice  
26 President for Student and International Affairs, Dr. Mauricio Gonzalez.
