# SENATE LEGISLATION

## JR-13F-2714

1 **JR-13F-2714 : Endorsement of Florida Board of Governors Inclusion of CITF Bonding in 2013-14 LBR**

2 **Whereas:** The Student Government of the University of North Florida was established to  
3 create a representative government through which the individual student voice can  
4 be heard, and which students can actively participate in this University by promoting  
5 cooperation among the student body, faculty, and administration, and;

6 **Whereas:** The Student Government of the University of North Florida was established to  
7 represent student concerns in all university wide matters; and

8 **Whereas:** Student Government believes activities, services and facilities that offer  
9 extracurricular programming are vital components to a university's campus and  
10 overall student success, and;

11 **Whereas:** During this Week of Welcome's Student Government Convention, students were  
12 asked "Do non-academic buildings (Student Union, Wellness Complex, etc.)  
13 contribute to the quality of your overall educational experience," and 93.6% of  
14 respondents said "yes," and;

15 **Whereas:** Construction of such facilities has historically been driven in large part by funding  
16 allocations from the leverage of the Capital Improvement Trust Fund (CITF) Fee,  
17 and;

18 **Whereas:** The Florida Board of Governors' (BOG) 2013-14 Legislative Budget Request (LBR)  
19 includes a request that the state government allow the bonding of the CITF fee,  
20 yielding an additional \$120 million of facilities funding for our university system next  
21 year;

22 **Therefore:** Let it be resolved that the Student Government of the University of North Florida  
23 commends the BOG for leading on this issue and including a request for bonding  
24 into the board's LBR, and;

25 **Furthermore:** Let this resolution be forwarded to each member of the Florida Board of Governors  
26 and State University System Interim Chancellor Dr. Jan Ignash.
