SENATE LEGISLATION

SB-13F-2715

1 *SB-13F-2713: 2715 UNF Organic Project*

2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government Senate,
5 responsible for funding only those entities that comply with the Student Government mission which is
6 to represent student concerns in all university wide matters while developing and promoting programs
7 and activities of practical value and interest to students, and;

8 Whereas: RSOs and currently enrolled A&S Fee-paying students may request funding for travel from the
9 Student Conference Travel Index according to 841.1 and;

10 Whereas: 841.2 Travel Requests fall under the jurisdiction of the B&A Committee and are not subject to full
11 Senate approval unless vetoed by the president or brought to the Senate floor as outlined in Title VIII
12 Chapter 840.10 according to 841.2 and;

13 Whereas: The request must receive a two-thirds (2/3) approval vote of the committee to pass and;

14 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational, social,
15 cultural, and recreational interests of the University of North Florida students and;

16 Whereas: The UNF Organic Project, are Activity and Service fee paying students, looking to enhance the
17 cultural and social interests of the students of the University of North Florida, and;

18 Whereas: The UNF Organic Project, in order to further enhance the cultural and social interests of the students
19 of the University of North Florida, are seeking funding for travel to the Powershift 2013 Conference
20 in Pittsburg, PA on October 17th to October 22nd, 2013.

21 Whereas: The UNF Organic Project, is requesting funding for the below items:

22 Vehicle (Charter Bus) = \$1,400
23 Total: = \$1,400

24 Therefore: Let it be enacted, by the University of North Florida Student Government, that
25 \$1,400 be expended from the Student Conference Travel Index 402028 to pay for the
26 above referenced items.
