## SENATE LEGISLATION SB-13F-2724

1		SB-13F-2724: Student Physical Therapy Association
2 3	Whereas:	The Student Government of the University of North Florida was established to represent stude concerns in all University wide matters, and;
4 5 6 7	Whereas:	The Budget and Allocations Committee is a standing committee of the Student Government Senat responsible for funding only those entities that comply with the Student Government mission which to represent student concerns in all university wide matters while developing and promoting program and activities of practical value and interest to students, and;
8 9	Whereas:	RSOs and currently enrolled A&S Fee-paying students may request funding for travel from the Student Conference Travel Index according to 841.1 and;
10 11 12	Whereas:	841.2 Travel Requests fall under the jurisdiction of the B&A Committee and are not subject to fu Senate approval unless vetoed by the president or brought to the Senate floor as outlined in Title VI Chapter 840.10 according to 841.2 and;
13	Whereas:	The request must receive a two-thirds (2/3) approval vote of the committee to pass and;
14 15	Whereas:	This purchase or activity reflects the genuine students interest and enhances the educational, social cultural, and recreational interests of the University of North Florida students and;
16 17	Whereas:	The Student Physical Therapy Association, are Activity and Service fee paying students, looking enhance the cultural and social interests of the students of the University of North Florida, and;
18 19 20	Whereas:	The Student Physical Therapy Association, in order to further enhance the cultural and social interest of the students of the University of North Florida, are seeking funding for travel to the Nation Student Conclave in Louisville, KY on October 24 <sup>th</sup> to October 27 <sup>th</sup> , 2013.
21	Whereas:	The Student Physical Therapy Association, is requesting funding for the below items:
22 23		Airfare: \$427.90 X 4 = \$1,711.60 = \$1,711.60
