SENATE LEGISLATION

SB-13F-2734

1 *SB-13F-2734: Kristin Karle*

2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government Senate,
5 responsible for funding only those entities that comply with the Student Government mission which is
6 to represent student concerns in all university wide matters while developing and promoting programs
7 and activities of practical value and interest to students, and;

8 Whereas: RSOs and currently enrolled A&S Fee-paying students may request funding for travel from the
9 Student Conference Travel Index according to 841.1 and;

10 Whereas: 841.2 Travel Requests fall under the jurisdiction of the B&A Committee and are not subject to full
11 Senate approval unless vetoed by the president or brought to the Senate floor as outlined in Title VIII
12 Chapter 840.10 according to 841.2 and;

13 Whereas: The request must receive a two-thirds (2/3) approval vote of the committee to pass and;

14 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational, social,
15 cultural, and recreational interests of the University of North Florida students and;

16 Whereas: The student, Kristen Karle, is an Activity and Service fee paying student, looking to enhance the
17 cultural and social interests of the students of the University of North Florida, and;

18 Whereas: Kristen Karle, in order to further enhance the cultural and social interests of the students of the
19 University of North Florida, is seeking funding for travel to the Society of Marine Mammalogy
20 Biennial Conference in Dunedin, New Zealand on December 6th to December 18th, 2013.

21 Whereas: Kristen Karle, is requesting funding for the below items:

22	Airfare:	1 student	X	\$500.00 per ticket	= \$500.00

25 **Therefore:** Let it be enacted, by the University of North Florida Student Government, that
26 \$500.00 be expended from the Student Conference Travel Index 402028 to pay for
