# SENATE LEGISLATION

## SB-14S-2744

1 **SB-14S-2744: Provisionary Language Amendment – Travel**

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Constitution of the Student Government of the University of North Florida grants the  
5 Senate certain legislative powers, of which is to pass bills. Bills may be legislative proposals  
6 to appropriate monies and adopt revisions to governing laws, and;

7 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government  
8 Senate, responsible for funding only those entities that comply with the Student Government  
9 mission, which is to represent student concerns in all university wide matters while  
10 developing and promoting programs and activities of practical value and interest to students,  
11 and;

12 Whereas: Chapter 823.6 states the Student Government Budget Provisionary language, as approved  
13 during normal legislative process, may be amended after September 1<sup>st</sup> for each fiscal year.

14 Whereas: Currently, the balance within index #402028 - Student Conference Travel is near depleted,  
15 and;

16  
17 Whereas: The following changes are being proposed to the Student Government Budget Provisionary  
18 language:

- 19 4. Travel expenses are only authorized from 402060 SG Executive, 402062 SG  
20 Business & Accounting Office, and 402028 Student Conference Travel. All  
21 other Indexes are prohibited from expending A&S Fee funding for travel.  
22 Only currently enrolled individual students and Registered Student  
23 Organizations may request funding from the Student Conference Travel  
24 Index. ~~One (1) No transfers transfer-~~ of funds up to \$10,000 may be made  
25 into the Student Conference Travel Index 402028 from the Special Request  
26 Index 402097 following the completion of a Centralized Budget Transfer  
27 Form.

31 **Budget Provisionary Language, effective immediately.**
