SENATE LEGISLATION

SB-14S-2768

SB-14S-2768: OP Revenue Utilization Act of Spring 2014

1

2 Whereas: The Student Government of the University of North Florida was established to represent student
 3 concerns in all University wide matters, and;

4 Whereas: Student Government is responsible for revising and updating the bylaws from time to time and;

5 Whereas: The Senate is the appropriate body charged with approve such revisions, and;
 6

7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by Student
 8 Senate;
 9

10 Whereas: Budgetary provisionary language establishes a cap on the amount of revenue Osprey Productions is
 11 able to generate, this cap is currently at \$25,000;
 12

13 Whereas: Due to the popularity and success of Osprey Productions concerts and events, specifically among
 14 paid participants, the \$25,000 cap is set to be met and should be changed so the additional revenue
 15 may go towards providing more popular Osprey Productions events to our fellow students.
 16

17 Therefore: The following changes are being proposed to: **Fiscal Year 2013/2014 Budget Provisionary**
 18 **Language.**

19 22. 402017 Osprey Productions — Ticket sale revenue from A&S Fee, Student
 20 Government sponsored events, ~~in an amount not to exceed \$25,000,~~ will be
 21 available to Osprey Productions for additional programming ~~for the current~~
 22 ~~Fiscal Year. An amount equal to the unexpended revenue generated over the~~
 23 current fiscal year in addition to the amount remaining within Osprey
 24 Production's revenue pool from previous years shall be allocated to Osprey
 25 Productions to be used for additional programming. Budget authority, up to
 26 \$100,000, shall be transferred from the Student Government Special Request
 27 Index 402097 to the Osprey Productions Index 402017.
 28

29 Therefore: Let it be enacted, by the University of North Florida Student Government, that the
 30 following changes to 2013/2014 Budget Provisionary Language be made effective.
