The Blue Foundation for a Healthy Florida Awards Philanthropic Grants Twelve Florida Non-profits Receive \$623,073

Jacksonville, Fla. -- The Blue Foundation for a Healthy Florida recently awarded \$623,073 to 12 non-profit Florida health clinics and community outreach programs. The funded programs care for a variety of Floridians who do not have access to appropriate healthcare options in their community. The Blue Foundation's Winter 2003 grants allow these programs to address serious healthcare issues such as diabetes, cervical cancer, mental health and access to prescription drugs. Grant winners were chosen from 163 proposals submitted to The Blue Foundation during the Winter 2003 grant cycle.

"These 12 grants represent the significant positive impact The Blue Foundation is having on increasing access to quality health-related services for uninsured and underserved Floridians," said Susan Towler, executive director of The Blue Foundation. "We are accomplishing our goal of providing caring solutions through grants that will educate, train and improve the lives of individuals and families throughout Florida."

The new awards mark \$3.3 million in contributions The Blue Foundation for a Healthy Florida has provided to Florida non-profits since the foundation began in March 2001. The impact of the 66 total grants presented so far touches all of Florida's shores and meets the diverse healthcare needs of Floridians living in the many communities in between.

"The Blue Foundation looks for innovative programs that advance the health and well-being of uninsured and underserved Floridians," Towler said. "Our primary focus on community health clinics and grassroots outreach programs provide greater resources and attention to those initiatives that serve our neediest populations."
