1 *SR-14F-2788: Revising Senator Scholarships in Senate P&Ps*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Senate is the legislative body of the University of North Florida's Student Government
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the
6 Student Body of the University of North Florida; and;

7 Whereas: Legislation dealing with necessary and proper revisions to the Senate Policies and Procedures
8 shall be considered by the Senate; and

9 Whereas: The current Senatorial Scholarship requirements conflict with the Internal Revenue Service's
10 rules on Tax-Free Scholarships and Fellowships. The Senatorial Scholarship requirements need
11 further revision to reflect the decisions made by the SG Scholarship Committee.

12 Therefore: The following necessary and proper revisions to the Senate Policies and Procedures are being
13 proposed:

Each Senator shall be responsible for submitting a Scholarship Requirements form (See Appendix Figure E on page 23) to the SG Administrative Secretary in the Rotunda prior to the end of their term. The Senate President will then collect all submitted forms and submit eligible Senators to the B&A Office. This form must include all signatures from the appropriate persons stating that the Senator has completed all of the aforementioned requirements.

Furthermore: Let it be enacted, by the University of North Florida Student Government that the proposed revisions to the Senate Policies and Procedures are made effective immediately.
