1 **SB-14F-2792 : Fiscal Year 2013/2014 Year-End Encumbrances**

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters; and

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student
5 Government Senate, responsible for funding only those entities that comply with the
6 Student Government mission which is to represent student concerns in all university
7 wide matters while developing and promoting programs and activities of practical
8 value and interest to students, and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the
10 educational, social, cultural, and recreational interests of the University of North
11 Florida students and;

12 Whereas: The provisionary language of the 2014/2015 Activity & Service Fee Budget specifies
13 that all 2013/2014 year-end encumbrances shall be funded from 402097 to the
14 appropriate departmental Indexes, following the normal legislative process and;

15 Whereas: The following Activity & Service Fee funded entities entered FY 2014/2015 with the
16 following outstanding encumbrances from FY 2013/2014:
