1 **SB-14F-2793: Amendments to Fiscal Year 2014-15 A&S Fee Budget Provisionary Language**

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Senate is the legislative body of the University of North Florida's Student Government  
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the  
6 Student Body of the University of North Florida; and;

7 Therefore: The following necessary and proper revision to the Fiscal Year 2014-15 A&S Fee Budget  
8 Provisionary language is being proposed:

9 Inasmuch as: The Proviso shall reflect the following changes:

11 **402501 Spinnaker Television**

12 ~~1. Spinnaker Television shall, at the request of the SG Elections Supervisor, provide a~~  
13 ~~public service announcement regarding Student Government elections to air during the~~  
14 ~~month prior to both fall and spring elections. Osprey Television shall also provide~~  
15 ~~public service airtime for official election forums and debates. Efforts shall also be made~~  
16 ~~to provide public service airtime for coverage of Student Government sponsored events~~  
17 ~~that may be of interest to students viewing Osprey Television.~~

19 **402502 Spinnaker Radio**

20 ~~1. As a condition of funding for 402502 Spinnaker Radio, Spinnaker Radio shall provide, at~~  
21 ~~the request of Student Government, a minimum of three public service announcements~~  
22 ~~per month to be recorded in a single session.~~

24 **Let it be enacted that the aforementioned amendments to the Fiscal Year 2014-15 A&S Fee**  
25 **Budget Provisionary Language be made effective September 1<sup>st</sup> 2014 in accordance with Title**  
26 **VIII § 823.6.**
