1 *SB-15S-2847: Appointment Regulation Act*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Senate is the legislative body of the University of North Florida's Student Government  
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the  
6 Student Body of the University of North Florida; and;

7 Whereas: Legislation dealing with necessary and proper statutory revisions to the System of Statutes shall  
8 be considered by the Senate; and

9 Therefore: The following necessary and proper revisions to the Student Government System of Statutes are  
10 being proposed in an effort to insure future compliance with the law and the balance of our  
11 democratic system:

12 **TITLE XIII: THE GOVERNMENT OVERSIGHT COMMITTEE STATUTES**

13 **Chapter 1302 Appointments**

14 1302.3 Appointment Process

- 15 A. All qualified candidates who meet all requirements for appointment shall be placed  
16 on the next regularly scheduled Government Oversight meeting agenda.
- 17 B. The Government Oversight Committee shall then interview all appointees and reach, by  
18 majority vote, consensus to  
19 either forward the candidate to the full Senate for confirmation, or deny the application.
- 20 | C. Upon forwarding for confirmation, the candidate shall be placed on the agenda for the next  
21 regularly  
22 | scheduled Senate meeting ~~agenda of the Senate~~ for a confirmation hearing.
- 23 D. The Senate shall, by two-thirds (2/3) vote, reach a  
24 consensus to either appoint the candidate to a Senate seat, or deny the application.
- 25 E. If confirmed, the appointee shall be sworn in as a Senator immediately.



# SENATE LEGISLATION

## SB-15S-2847

***SB-15S-2847: Appointment Regulation Act***

F. If there are still candidates seeking confirmation after all vacant seats are filled, those candidates' applications shall remain active for ninety (90) days. In the event of an open seat, candidates for Senatorial confirmation will first be selected from the pool of active applications.

G. The process of appointment shall be conducted in the order in which the candidate turned in their Senate Appointee Information Page of their Senate Appointment Packet.

Therefore: Let it be enacted that the aforementioned amendments to the Title XIII be made effective immediately.
