- 2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while developing
7 and promoting programs and activities of practical value and interest to students, and;
- 8 Whereas: RSOs and currently enrolled Activity and Service Fee-paying students may request funding for
9 travel from the Student Conference Travel Index according to 841.1 and;
- 10 Whereas: 841.2 Travel Requests fall under the jurisdiction of the Budget and Allocations Committee and
11 are not subject to full Senate approval unless vetoed by the President or brought to the Senate
12 floor as outlined in Title VIII Chapter 840.10 and according to 841.2 and;
- 13 Whereas: The request must receive a two-thirds (2/3) approval vote of the committee to pass and;
- 14 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
15 social, cultural, and recreational interests of the University of North Florida students and;
- 16 Whereas: Andres Tortolero, is a Activity and Service Fee-paying student, looking to enhance the cultural
17 and social interest of the students of the University of North Florida, and
- 18 Whereas: Andres Tortolero, in order to further enhance the cultural and social interests of the students of
19 the University of North Florida, is seeking funding to attend the Southeast and Mid-Atlantic
20 Marine Mammal Symposium, located in Virginia Beach, Virginia, on March 27, 2015 through
21 March 29, 2015;
- 22 Whereas: Andres Tortolero, is requesting funding for the below items:
