JOAN WELLHOUSE NEWTON



Joan Wellhouse Newton is currently Chairman Emeritus (since 2000) and co-founder of Regency Centers Corporation, a publicly traded Real Estate Investment Trust. Mrs. Newton and her husband, Martin Stein, founded the company in 1963 and she and her son, Martin Stein, Jr., took the company public on the New York Stock Exchange on October 28, 1993.

AMY BUGGLE

Early intervention teacher and executive director of DLC (Developmental Learning Center) Nurse & Learn

DLC, which Buggle founded 24 years ago, serves more than 130 special-needs children per year in preschool, after-school programs and summer camp. In addition, it provides nursing care and physical, occupational and speech therapy. In 2012, Buggle started a voluntary prekindergarten program for 4-year-olds with and without disabilities, formed a night support group for parents and continued to develop creative fund-raising efforts in a tough economy. Buggle inspired volunteers to donate more than 332 hours and the community to provide more than \$250,000 for scholarships. "Amy is so much more than a teacher, administrator, facilitator and fund raiser," her nominator said. "She juggles an overwhelming schedule and yet maintains daily interaction with students and has amazing knowledge of each individual student, their respective needs and accomplishments."



SARAH SCHAEFER

Math curriculum specialist for The Bolles School

Schaefer's frustration with students who could solve basic math problems but couldn't apply their knowledge led her to Singapore – literally. Schaefer was awarded a \$10,000 grant to research math curriculums and found that Singapore fit her vision. Students still learn traditional math facts, but use concrete, pictorial and abstract methods to help them understand its concepts. She trained elementary and middle school teachers at Bolles in the methodology and is now a consultant for seven local schools, four in the state and several outside Florida. Last summer, she obtained another \$10,000 grant and spent 10 days in Singapore delving further into the subject. Since its implementation, Bolles students are scoring higher in math on standardized tests. In the past year, Schaefer has written seven summer workbooks for students in grades 1-6. She also created and runs the Bolles Math Olympiad team and volunteers at the Children's Home Society.



SHERRI JACKSON

Professor of psychology and chair of the Division of Social Sciences at Jacksonville University

Jackson has written four textbooks on statistics and research methods with the final one published in 2012. Not only have they been adopted at JU and the University of North Florida, but also many colleges and universities in the United States and abroad. She has won every faculty award JU bestows, including Professor of the Year in 2004, University Woman of the Year in 2005 and the University Award for Excellence in Teaching in 2009. Last fall, she was nominated for a teaching excellence award given by the American Psychological Association's Society for the Teaching of Psychology and gave the keynote address at the Sigma Tau Delta Research Conference at UNF. She serves as a role model for her female students and a mentor to colleagues. "As a faculty member at a small university, authoring four successful textbooks is a singular achievement," her nominator wrote.



CHERYL QUARLES-GASTON

Principal of Carter G. Woodson Elementary School

Under her leadership, Woodson went from an F school to an A. Quarles-Gaston became principal shortly after Woodson received a failing grade from the state in 2007. After two years, the grade improved to a C, but remained at that level for three years. So she lead the faculty through a series of discussions challenging their beliefs about the potential of Woodson's students, 98 percent of whom are on a free or reduced-lunch program and live in a low-income neighborhood. Students began wearing uniforms, parents adhered to a dress code when visiting Woodson and transportation was provided for after-school and Saturday enrichment activities. Teachers worked together to develop a consistently rigorous program. It resulted in Woodson becoming among the highest-performing schools in 2012 and Quarles-Gaston receiving the 2012 Leonard Miller Principal Leadership Award, which has a \$10,000 cash prize.

VOLUNTEER SERVICE



BARBARA TIDWELL

President and founder of the Wildlife Rescue Coalition of Northeast Florida, Inc.

Tidwell founded the nonprofit, which cares for injured, orphaned and displaced wild animals, in her rural Westside backyard in 2003. The sanctuary moved to larger quarters on donated land on Seaboard Avenue in 2005. The center now takes in more than 2,000 animals a year and responds to 50 to 100 calls, emails and website inquiries per day. She responds to calls from the Jacksonville Sheriff's Office when help is needed with a suspected rabid raccoon or sick

animal at night and on holidays. Over the past 10 years, she has inspired donors to give money, supplies, gifts and in-kind services, and continues to solicit donations. Tidwell has done this while operating four licensed assisted-living facilities for the elderly. Last year, the Safari Club invited her to teach 900 children about living in harmony with nature.

KATHRYN MCAVOY

Founder and executive director of The Performers Academy



McAvoy renovated a building at 3674 Beach Blvd. as a hub for the performing arts. She has worked with instructors in each discipline to establish a "Taste of the Arts" program where kids can get a sampling of everything. In her unpaid position, she devotes more than 50 hours a week to provide programs for at-risk and foster children to excel in the arts, be motivated to complete school and receive college scholarships in the performing arts. Many are trained at no cost and sometimes at her own expense. She even started a recreation acting class for autistic children. Other achievements include establishing a homework lab, creating a "Bring the Books to Life" campaign, providing free performances

across the city and partnering with organizations to bring arts projects to the community.

KAREN NIGARA

District 6 commander and national legislative chair of Veterans of Foreign Wars



Nigara is a retired Army lieutenant colonel who served in Kosovo, Haiti and Korea with several assignments in Washington, D.C. After 16 years of volunteer service for the VFW, she was elected commander of District 6, which encompasses Northeast Florida and now has 5,096 members. "She thoroughly energized District 6," her nominator said. Under her guidance, members contributed more than 23,000 hours to such activities as counseling current conflict veterans, patriotic programs for students and teachers and recognizing outstanding police and firefighters. It also gained 617 new members. In addition, Nigara coordinated a program to give handmade newborn gift bags

to women in Veterans Affairs prenatal care. Nationally, she was the first woman appointed as legislative chair.

BERNADETTE MORAN

Board Member and past president of The Arc Jacksonville



Moran has been a tireless advocate for children and adults with intellectual and developmental disabilities for much of her life. In early 2012, she took on the challenge of raising \$7.5 million to create the Arc Village, a residential community for adults with disabilities. Another goal is to secure federal and state funding to provide the balance of the required \$20 million. Moran joined the Arc board in 1994 and has promoted the inclusion of people with disabilities in all aspects of life and their belief in the value of what they have to offer. She has inspired her daughter, Moria Rossi, to never let Down syndrome

prevent her enjoying a fulfilled life. Moran was appointed last September to the Florida Developmental Disabilities Council, an advocacy and planning body.

CANDANCE HODGKINS

President/CEO of Gateway Community Services, Inc.

Since taking over leadership in January 2012, Hodgkins identified areas that needed improvement, raised staff morale, successfully fought funding cuts and identified new funding sources. Gateway's grounds have undergone a major renovation while the building of a day-care center is almost complete. Hodgkins has administrative and clinical program responsibility for the

\$15 million organization, which provides substance abuse treatment and

prevention services for adults, children and families. She has been instrumental in bringing science-based research to clients and staff and has developed a free-standing research department. She often trains workers in substance abuse and volunteers in many organizations. For example, she is consultant and volunteer with the Boselli Foundation, run by her son, Tony Boselli, former offensive tackle for the Jaguars. Hodgkins has a doctorate from the University of Florida in counselor education with a specialization in addictions.



SUSAN TOWLER

Executive director of community affairs for Florida Blue Corp. and vice president of Florida Blue Foundation

Towler oversees a community investment program that focuses on health care, education and human services. Florida Blue employees donated more than 22,000 volunteer hours in 2012 at an estimated value of \$480,000. In the company's 2012 campaign, corporate gifts and employee giving exceeded

\$2 million. Towler proposed and oversaw two major employee volunteer in initiatives this past year.

Beginning in January 2013, Florida Blue employees will receive eight hours of paid time off to volunteer for a nonprofit or school of their choice. The second initiative is nominating exceptional volunteers as the "Florida Blue Volunteer of the Year," which provides a cash award to the nonprofit of their choice.

In addition to her professional accomplishments, Towler is chairing Leadership Florida, which brings together civic, government and business leaders to discuss the state's most critical issues.



NINA WATERS

President of The Community Foundation

Under her watch, the foundation has changed significantly. The organization, which manages 444 charitable funds, has broadened its ability to serve others, including aging adults, artists, organizations, neighborhood revitalization and the Jacksonville Public Education Fund. Because of her relationship with several donors, it has become the largest community foundation in Florida, going from \$156 million to \$254 million in assets last year. Waters' counsel is sought after

by nonprofit leaders, budding philanthropists, business leaders and government officials. Without her vision and tenacity, there would be no infrastructure to support reform, her nominator said.



ISABELLE SPENCE

Executive director of Leadership Jacksonville

In 2012, Spence spearheaded the creation and launch of the Legacy Series, video conversations with community leaders who have had a lasting impact on the quality of life in Jacksonville. After each installment premieres on WJCT, it can be viewed on the station's website. Leadership Jacksonville's website, business partners' websites and the YouTube channel. Spence devoted a great deal of her own time to developing a plan of what the series would look

like and in finding business partners to help support for it. So far, Fran Kinne and Alton Yates have been depicted. In May, Fred Schultz's video will be released. Others scheduled this year are Bob Shircliff and Delores Barr Weaver. Leadership Jacksonville is known for its yearlong adult and high school student programs. During Spence's tenure, a two-day executive program for CEOs new to the community and summer collegiate program were added.

KEYNOTE SPEAKER

Martha Barnett, Partner Holland & Knight Law Firm

"Gender Matters"



Martha W. Barnett is a partner in the law firm of Holland & Knight. The first woman lawyer hired at the firm in 1973, Martha is a member of the firm's Government Section and focuses on public policy, with special expertise in state and local taxation and governmental/administrative law. She was the first woman to hold the position of Chair of the American Bar Association of Delegates, the association's policy-making body, and served as American Bar Association President in 2000-2001.

Martha attended Tulane University for her Bachelor degree, and she received her Juris Doctorate from the University of Florida. In 2006 she was honored as a Distinguished Alumnus by the University of Florida.

In 2011, Martha received the prestigious Lifetime Leadership Award, given jointly by Leadership Tallahassee and the Greater Tallahassee Chamber of Commerce. The Lifetime Leadership Award recognizes an individual who has made significant, tangible leadership contributions to the Tallahassee community for more than 25 years.

She has served Holland & Knight in many leadership roles, including Executive Partner of the Tallahassee office; and she has served the State of Florida in numerous gubernatorial appointments including as the Chair of the Florida Commission on Ethics.
