# SENATE LEGISLATION

## SB-15F-2908

1 *SB-15F-2908: Cru*

2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while developing and  
7 promoting programs and activities of practical value and interest to students, and;

8 Whereas: RSOs and currently enrolled Activity and Service Fee-paying students may request funding for  
9 travel from the Student Conference Travel Index according to 841.1 and;

10 Whereas: 841.2 Travel Requests fall under the jurisdiction of the Budget and Allocations Committee and  
11 are not subject to full Senate approval unless vetoed by the President or brought to the Senate  
12 floor as outlined in Title VIII Chapter 840.10 and according to 841.2 and;

13 Whereas: The request must receive a two-thirds (2/3) approval vote of the committee to pass and;

14 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational, social,  
15 cultural, and recreational interests of the University of North Florida students and;

16 Whereas: are Activity and Service Fee-paying students, looking to enhance the cultural and social interest of  
17 the students of the University of North Florida, and

18 Whereas: Cru, in order to further enhance the cultural and social interests of the students of the University  
19 of North Florida, to have 10 students attend the Cru Southeast Winter Conference in Atlanta,  
20 Georgia from December 29<sup>th</sup> 2015 to January 1<sup>st</sup> 2016

21 Whereas: Cru, is requesting funding for the below items:

22	Registration	= \$2,000.00
23	Total	= \$2,000.00

24 Therefore: Let it be enacted, by the University of North Florida Student Government, that \$2,000.00 be  
25 expended from the 2015-2016 FY Student Conference Travel Index 402028 to pay for the above  
26 referenced items.
