## JR-15F-2914

***JR-15F-2914: Hodges Stadium***

- 2 **Whereas:** The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;
- 4 **Whereas:** The Senate is the legislative body of the University of North Florida's Student Government given  
5 the responsibility of carrying out such legislative acts that are necessary and proper for the Student  
6 Body of the University of North Florida; and;
- 7 **Whereas:** The University of North Florida professes a responsibility to the student body's well being and  
8 safety as basic human rights; and;
- 9 **Whereas:** Hodges Stadium is an important aspect of life not only to athletes, coaches, and trainers but to  
10 students, spectators, guests of UNF, and outside events hosted at Hodges Stadium; and;
- 11 **Therefore:** The following necessary and proper renovations to Hodges Stadium as recommended by the  
12 Student Athletic Advisory Council are being proposed in an effort to insure future compliance  
13 with the law and the balance of our democratic system:
- 14 **Therefore:** Let it be enacted that we, the Student Government of the University of North Florida,  
15 recognize and support the necessity of repairs to Hodge's stadium, the Strength and  
16 Conditioning room, and the stadium locker rooms so that the health and safety of students  
17 and athletes are protected for years to come.
- 18 **Furthermore:** Let this resolution be forwarded to President Delaney, Vice President for Administration  
19 and Finance Shuman, and Vice President for Student and International Affairs Gonzalez.
