SB-08S-2217: Revision to Election Commission Definition

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government, given the responsibility of carrying out such legislative acts
6 that are necessary and proper for the Student Body of the University of North
7 Florida, and;

8 Whereas: Title VI is in need of a minor revision, and;

9 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
10 considered by the Student Senate, and;

(. Whereas: The following proposed change is a revision to 600.2.K:

12 K. Elections Commission - The Ad-Hoc Committee, led by the Elections
13 Supervisor Commissioner, that is responsible for ~~all decisions and~~
14 ~~commitments surrounding all~~ enforcing all rules and procedures outlined
15 in the University of North Florida's Student Government Constitution and
16 Statutes that are applicable to candidates in General, Inter-College and
17 Special Elections.

18 Whereas: In order to better serve the Student Body of the University of North
19 Florida and promote order within the Student Senate, this revision to the
20 definition of Elections Commission is needed.

22 **Therefore: Let it be enacted, by the University of North Florida Student Senate, that this**
23 **revision to Title VI be made effective July 1st, 2008**
