### *JR-08S-2224: Robinson Theater*

- 2   Whereas:     The Student Government of the University of North Florida was established to  
3                   represent student concerns in all University wide matters, and;
- 4   Whereas:     In representing student concerns, Student Government as a whole believes that  
5                   this concern should be addressed; and
- 6   Whereas:     The University Administration purchased most of the Robinson Student Life  
7                   Center (Building 14) from Student Government in 2001; Student Government and  
8                   other student programming offices will relocate from Building 14 to the new  
9                   Student Union in April 2009; and
- 10   Whereas:    The Robinson Theater is considered part of Building 14; and
- 11   Whereas:    Student Government intends to continue the use of the Robinson Theater  
12                (Building 14A) for various student programming and activities;
- 13   **Therefore:   The Student Government of the University of North Florida resolves to make**  
14                **it known to Board of Trustees, University President, University Vice-**  
15                **President of Student Affairs, and University Vice-President of**  
16                **Administration and Finance that Student Government will continue to fund**  
17                **operations and coordinate reservations of the Robinson Theater so that this**  
18                **space can be utilized by student organizations on campus.**
