SENATE LEGISLATION

SB-08SA-2226

1 *SB-08SA-2226 : Amendment to Title VIII 811.6, 811.11, and 840.4*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: The Budget and Allocations Committee is the standing committee responsible for the
10 maintenance and approval of revision to Title VIII: The Finance Code and;

11 Whereas: To ensure the Student Body of the University of North Florida is represented directly by its
peers the following changes are to be made to Title VIII: The Finance Code:

13 811.6 The B&A Chairperson shall meet with the SG Business Manager and/or SG
14 Accountant(s) to review funding requests for compliance with Title VIII
15 prior to establishing the Agenda for the B&A Meeting at which it will be
16 considered. The B&A Chairperson shall present to the committee all
17 properly submitted requests.

19 ~~811.11 The B&A Chairperson shall present to the committee all requests that meet~~
20 ~~the requirements set forth in the B&A Policies and Procedures and Title~~
21 ~~VIII. The B&A Chairperson shall determine if a request has been properly~~
22 ~~submitted by meeting with the SG Accountant(s) and SG Business Manager.~~

24 840.4 A properly submitted request for Special Request Funding or Travel by
25 RSOs or individuals shall be received in the B&A Chairperson's mailbox a
26 minimum of five business days prior to the next scheduled B&A Committee
27 Meeting and a minimum of six weeks prior to the event or travel date and
28 shall consist of nineteen date-stamped and stapled copies of the following
29 materials:

31 1. Request Form, signed by the appropriate advisor, ~~SG Business~~
32 ~~Manager~~ SG B&A Chairperson, SG Treasurer, Senate Sponsor,
33 and club president.
