## SB-08SA-2228

1 **SB-08SA-2228 : Athletic Training Students' Association Travel Request**

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Athletic Training Students' Association is a club in good standing under Club Alliance  
12 enhancing the cultural and social interests of the students of the University of North Florida,  
13 and;

14 Whereas: Athletic Training Students' Association, in order to further enhance the cultural and social  
15 interests of the students of the University of North Florida, is seeking funding for travel to  
16 the NATA Annual Meeting and Clinical Symposia in St. Louis, MO., departing Tuesday,  
17 June 17, 2008 and returning Saturday June 21.

18 Whereas: Athletic Training Students' Association is requesting funding for the below items:

19 Airfare: 8 students x \$211.00 = \$1,688.00

20 **Total: = \$1,688.00**

23 **that \$1,688.00 from the Student Conference Travel Index 402028 be allocated**
