# SENATE LEGISLATION

## SB-08F-2248

1 **SB-08F-2248 : Osprey Lacrosse Travel Request**

2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government Senate,  
5 responsible for funding only those entities that comply with the Student Government mission which is  
6 to represent student concerns in all university wide matters while developing and promoting programs  
7 and activities of practical value and interest to students, and;

8 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational, social,  
9 cultural, and recreational interests of the University of North Florida students and;

10 Whereas: Osprey Lacrosse at UNF is a student organization that is registered and in good standing with Club  
11 Alliance. Lacrosse is composed of Activity and Service Fee- paying students looking to enhance the  
12 cultural and social interests of the students of the University of North Florida, and;

13 Whereas: Osprey Lacrosse, in order to further enhance the cultural and social interests of the students of the  
14 University of North Florida, is seeking funding for travel to the Southeastern Lacrosse Conference  
15 (SELC) Fall Meeting in Atlanta, GA departing August 2, 2008 and returning August 7, 2008.

16 Whereas: Osprey Lacrosse is requesting funding for the below items:

17	Lodging:	(2 nights x \$189) + (2 nights x \$249) = \$876 x 0.5	= \$438
18	Transportation Rental:	1 vehicle x \$126.22	= \$126.22
19	Transportation Fuel:	(740 miles / 15 mpg) x \$4.25/gallon	= \$210
20	Food:	\$91 per student x 4 students	= \$364
21	<b>Total:</b>		<b>= \$1,138.22</b>

22 **Therefore: Let it be enacted, by the University of North Florida Student Government,**  
23 **that \$1,138.22 from the Student Conference Travel Index 402028 be allocated**  
24 **to pay for the above referenced items.**
