# SENATE LEGISLATION

## SB-08F-2253

1 *SB-08F-2253 : Amendment to Title VIII*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: The Budget and Allocations Committee is the standing committee responsible for the  
10 maintenance and approval of revision to Title VIII: The Finance Code and;

11 Whereas: To ensure the Student Body of the University of North Florida is represented directly by its  
12 peers the following changes are to be made to Title VIII: The Finance Code:

13 841.2 A Individuals requesting travel funding are limited to \$500 one time per Fiscal  
14 Year and the Student Government Senate may fund no more than ~~three (3)~~  
15 Five (5) students traveling to the same conference.

17 **Therefore: Let it be enacted, by the University of North Florida Student Government,**  
18 **that the above referenced amendments be made to Title VIII: The Finance**  
19 **Code of the Student Government of the University of North Florida effective**  
20 **immediately.**
