

# Founded

In 1944, the Florida Hospital Service Corp., the forerunner of Blue Cross of Florida, began operations in Jacksonville with a staff of four.

In 1946, the Florida Medical Services Corp. was formed, eventually becoming Blue Shield of Florida.

The two companies consolidated in 1980 to form Blue Cross and Blue Shield of Florida (BCBSF).

#### **Organizational Structure**

Blue Cross and Blue Shield of Florida manages its business through three areas:

Health Business – Our core business provides a full spectrum of health care plans and services. It carries the strong Blue Brand and represents

our largest customer base – approximately 3.8 million members – and a 29 percent market share, more than double the nearest competitor.

Government Business – This business sector focuses primarily on traditional Medicare program administration and diversification into related markets.

This sector is managed by the BCBSF subsidiary First Coast Service Options Inc. (FCSO).



Specialty Products – The company offers specialty products to provide an array of solutions for company benefit and employee financial security needs. Major product lines include life, disability, dental, long-term care, workers' compensation and third-party administration.

These products are managed by Florida Combined Life Insurance company Inc.



#### Vision, Mission and Values

Vision – "A company focused primarily on the health industry, delivering value through an array of meaningful choices."

Mission – Our Mission forms the bedrock of our strategic direction. It establishes a unique role for our company to advance the health and well-being of all Floridians and underscores our commitment to use the company's resources not only to serve our members, but also to pursue community and public policy solutions that improve the quality, accessibility and efficiency of health care for all Floridians.

Products Offered – Through the parent company, its family of subsidiaries and joint ventures, BCBSF offers a broad choice of affordable, health-related products and services.

BCBSF offers health care choices that include traditional indemnity health plans, PPO health products, consumer-driven health products, long-term care, Health Savings Accounts, and



wellness and care management programs, among others.

Health Options Inc. and its controller affiliate, Capital Health Plan, offers HMO products – including Medicare Advantage – and wellness programs.

Life and Specialty Ventures, LLC, a holding company jointly owned with

Arkansas Blue Cross and Blue Shield (ABCBS), markets a variety of products through Florida Combined Life Insurance Company Inc., and Florida Combined Insurance Agency. Products include life, disability, dental, workers' compensation administrative services, flexible spending and health reimbursement accounts.

FCSO is a third-party administrator for the federal Medicare program in Florida and Connecticut.

Incepture offers both permanent and temporary staffing, software training and print-to-mail services.

Availity, LLC, BCBSF's joint venture with HUMe-FL Inc., a subsidiary of Humana Inc., is a leading provider of electronic administrative, financial, and clinical health care information services, optimizing the flow of information between multiple health care participants, including physicians, hospitals, health plans and other health care professionals. Availity has registered more than 14,000 physician sites, including all 208 hospitals in Florida, for use of its health care information exchange portal.

The Availity<sup>®</sup> Gateway is one of the fastest growing electronic information exchanges in history, processing 100 million billable transactions in 2005.

#### Enrollment

BCBSF and its family of subsidiaries serve more than 8.3 million people.

In its Health Business alone, BCBSF serves approximately 3.8 million members, a 29 percent share of the overall Florida health insurance market.

#### **Financial Performance**

In 2005, BCBSF experienced balanced financial

performance. BCBSF reported consolidated total revenue of \$6.98 billion and a profit margin of 5 percent.

BCBSF experienced its 17<sup>th</sup> consecutive year of positive financial performance in 2005.

#### **Employees**

BCBSF is one of Jacksonville's largest private employers and a major force in both the local and state economy.

Statewide, the company provides employment for 9,300 individuals in Jacksonville, Miami, Fort Lauderdale, Orlando, Tampa and Pensacola.

In 2005, our employees logged 30,000 hours volunteering in our communities. In addition, our employees have been number one in giving to the United Way campaign of Northeast Florida for the past seven years.

BCBSF created The Blue Foundation for a Healthy Florida Inc. in 2001.


The Blue Foundation for a Healthy Florida works to positively impact Florida's many different health care challenges with a particular focus on the health and well-being of the underserved and uninsured. As of year-end 2005, The Blue Foundation has made charitable contributions of approximately \$5.5 million through 103 grants to Florida non-profit organizations. In 2005, BCBSF again displayed its strong commitment to charitable giving and made contributions to more than 380 non-profit organizations that touch the lives of people in all of Florida's 67 counties. The company made charitable contributions totaling \$19.5 million in 2005.

#### **Miscellaneous Facts**

BCBSF is the oldest, largest, most recognized health plan provider in the state of Florida.

The Blue Cross and Blue Shield system of plans consists of 39 independent and locally operated Blue Plans with a total national enrollment of more than 93 million at year-end 2005, which equals one in three Americans.

Blue Plans have experienced 11 consecutive years of positive enrollment.



In 2005, BCBSF and its HMO subsidiaries processed more than 54 million claims on behalf of our members with approximately \$9.27 billion paid to physicians and other providers for our members' health care services.

In addition, our Medicare subsidiary, FCSO, paid out \$15.9 billion in benefits on behalf of the federal Medicare program.

In 2005, more than 3.1 million of BCBSF 3.8 million health plan members filed claims or made inquiries related to their health care coverage.

In 2005, BCBSF processed approximately 215,000 claims each business day, and paid on average \$37 million each day (\$777 million a month) to physicians and other providers for our members' health care services.

As a tax-paying, mutual insurance company, BCBSF paid more than \$270 million in state and federal taxes in 2005.

BCBSF celebrated its 60<sup>th</sup> anniversary in 2004, and the Blue Cross and Blue Shield Association celebrated its 75<sup>th</sup> anniversary in 2004.

In 2005, *Diversity Inc.* magazine named BCBSF to its listing of 25 noteworthy U.S. companies for its dedication to diversity in the workplace. In 2004, *Onyx* magazine awarded the company its Statewide Award for Diversity and Inclusion, recognizing the company for its dedication to diversity and commitment to Florida communities.
