# SENATE LEGISLATION

## SB-08F-2273

### *SB-08F-2273 : Increase Expenses*

1

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts that  
6 are necessary and proper for the Student Body of the University of North Florida;  
7 and

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered  
9 by Student Senate; and

10 Whereas: The Elections Code is in need of revision due to the increased cost of campaign  
11 materials. This has caused an excessive burden on candidate's ability to promote  
12 effectively; and

13 Whereas; The following revisions are being made to Title VI;

14 605.3 Expenses

15  
16 B. Campaign Expenses of candidates shall be limited to the following:

17  
18 1. A Presidential Ticket shall be limited to ~~two thousand dollars (\$2000.00).~~  
19 Three thousand dollars Five hundred dollars (\$3,500.00).

21 2. Senate Candidates

22  
23 a. Senate At-Large and the graduate seat (Seats 1-41) shall be limited  
24 to ~~two hundred and fifty dollars (\$250.00).~~ five hundred dollars  
25 (\$500.00) per candidate.

28 Therefore: Let it be enacted, by the University of North Florida Student Government that  
29 the proposed revisions to Title VI be made effective January 1<sup>st</sup>, 2009.
