2	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters; and
4 5 6 7	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida; and
8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate; and
10 11 ?	Whereas:	The Elections Code is in need of revision due to the increased cost of campaign materials. This has caused an excessive burden on candidate's ability to promote effectively; and
13	Whereas;	The following revisions are being made to Title VI;

A Presidential Ticket shall be limited to two thousand dollars (\$2000.00). Three thousand dollars Five hundred dollars (\$3,500.00). 2. Senate Candidates a. Senate At-Large and the graduate seat (Seats 1-41) shall be limited to two hundred and fifty dollars (\$250.00). five hundred dollars (\$500.00) per candidate. Let it be enacted, by the University of North Florida Student Government that the proposed revisions to Title VI be made effective January 1st, 2009.
