SENATE LEGISLATION

SB-08F-2282

1 ***SB-08F-2282 : Election time***

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government given the responsibility of carrying out such legislative acts that
6 are necessary and proper for the Student Body of the University of North Florida;
7 and

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered
9 by Student Senate; and

10 Whereas: The Elections Code is in need of revision due to the boundaries it holds for
11 performing a precise election; and

12 Whereas: The current window for an election dates allow only three weeks difference in the
13 election dates and do not take into consideration conflicts with University scheduling
14 such as holidays, breaks, date changes and other special events; and

15 Whereas; The following revisions are being made to Title VI;

16 603.1 General Elections

18 B. Spring Elections shall take place no less than three (3) weeks and no more
19 than seven (7) weeks prior to the end of the Spring Semester. ~~Spring~~
20 ~~Elections shall take place no less than fifty (50) weeks and no more than~~
21 ~~fifty-four (54) weeks from the previous Spring Election.~~

23 **Therefore: Let it be enacted, by the University of North Florida Student Government**
24 **that the proposed revisions to Title VI be made effective January 1st, 2009.**
