1 **SB-08F-2294: Student Physical Therapy Association**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Student Physical Therapy Association is enhancing the cultural and social interests of
12 the students of the University of North Florida, and;

13 Whereas: The Student Physical Therapy Association, in order to further enhance the cultural and social
14 interests of the students of the University of North Florida, is seeking funding to attend The
15 Combined Sections Meeting in Las Vegas, Nevada from Sunday, February 8th, 2009 to
16 Friday, February 13th, 2009.

17 Whereas: The Student Physical Therapy Association is requesting funding for the below items:

18	Registration:	7 students	X	\$60.00	= \$420.00
19	Airfare:	7 tickets	X	\$150.00	= \$1,050.00
20	Food:	7 students	X	\$144.00	= \$1,008.00
21	Total:				= \$2,478.00

22 **Therefore:** Let it be enacted, by the University of North Florida Student Government,
23 that \$2,478.00 be expended from the Student Conference Travel Index
24 402028 to pay for the above referenced items.
