## SB-09SB-2346

1 **SB-09SB-2346 : SG Business and Accounting Special Request**

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: SG Business and Accounting, in order to further enhance the cultural and social interests of  
12 the students of the University of North Florida, is seeking funding for window coverings for  
13 Bldg 58 East Student Union and portions of Bldg 58 West--- roller window shades.

14 Whereas: SG Business and Accounting is requesting funding for the below items:

15 Window Shades for Bldg 58 East Student Union and portions of Bldg 58 West

16 Quantity: 246 = \$74,271

20 **Therefore:** Let it be enacted, by the University of North Florida Student Government,  
21 that \$74,271 from the Special Request Index 402097 be transferred to Index  
22 402062 to pay for the above referenced items.
