# SENATE LEGISLATION

## SB-09F-2359

1 ***SB-09F-2359 : Public Relations Student Society of America Travel Request***

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Public Relations Student Society of America is an Activity and Service fee paying student  
12 looking to enhance the cultural and social interests of the students of the University of North  
13 Florida, and;

14 Whereas: Public Relations Student Society of America, in order to further enhance the cultural and  
15 social interests of the students of the University of North Florida, is seeking funding for  
16 travel to the 2009 National PRSSA Conference in San Diego, California from November 5<sup>th</sup>  
17 2009 to November 10<sup>th</sup> 2009.

18 Whereas: Public Relations Student Society of America is requesting funding for the below items:
