SB-09F-2366

1 **SB-09F-2366: Transfer of Funds**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission, which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This transfer or activity reflects the genuine students interest and enhances the, social,
10 cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Government has the obligation to promote student activities and service
their general interests; and

13 Whereas: Since July 1, 2009 Student Government Senate has approved \$510,527 and
14 currently does not have the necessary funding to accommodate the anticipated
15 future requests made to the Student Senate; and

16 Whereas: In order for Student Government to continue to allocate and expend student
17 activity and service fees to benefit the student body in general, it is requesting that
18 \$150,000 be transferred from the Fund Balance Index 402000 to the Special
19 Request Index 402097.

20 **TOTAL: \$150,000**

21 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
22 **that \$150,000 from the Fund Balance Index 402000 be transferred to Special**
23 **Requests Index 402097.**
